Message from Jeff Gilman, Executive Director

Our Mission states: "The Redwood Gospel Mission, in the grace and power of Jesus Christ, mobilizes our community to minister to the needy so that lives are transformed." As you can imagine, living out that mission statement was a challenge for us in 2020-2021 much as it was for so many people and organizations throughout the world.

The biggest challenge we faced was how to serve the most people in the safest, most effective way possible, especially in light of the fact that the Mission is predominantly a volunteer organization, and the pandemic virtually eliminated our volunteers from being able to serve.

COVID restrictions initially required the Mission facilities to operate at twenty-five percent capacity. And the County Regulations restricted us from opening our facilities to "walk-ins" off the street. But with the challenges came many opportunities that never would have happened without COVID and the associated restrictions.

One of the best opportunities came in the form of collaboration. For 15 months, the Mission partnered with Alliance Redwoods to house and care for hundreds of the most vulnerable homeless people in our county.

Other amazing partnerships included St. Joseph Health, who provided four different medical clinics at Mission Facilities each week; plus West County Health Services, which provided medical care for residents who were staying at the camp. Through the pandemic, The Mission became a vital link for Sutter, Memorial and Kaiser hospitals, all of whom are prohibited by law from discharging homeless guests to the streets.

Similarly, that access was available to Sonoma County Law Enforcement Agencies and other agencies working with vulnerable and abused populations.

Because of the restrictions in the number of guests coming into the Mission, we found creative ways of getting the Mission to the guests. Our Mobile Shower Unit, known as "Highways and Hedges" expanded into all parts of the County, to Cloverdale, Healdsburg, Guerneville, Rohnert Park, Petaluma and multiple locations in Santa Rosa, reaching out with showers, clean clothes, personal hygiene items, as well as the gospel, prayer, and spiritual counseling.

The COVID restrictions also drastically affected our various outreach events such as the City Kids Festival, Homeless Birthday Party and the Great Thanksgiving Banquet, but at the same time gave us opportunity to engage with people in new and creative ways.

Because we were inhibited from utilizing the Sonoma County Fairgrounds for the 2020 Thanksgiving event, we pivoted to a "drive-through" event that included turkeys and food boxes for over three thousand people in seven hundred families and featured a short-range FM radio transmission of a Thanksgiving Gospel Message.



By late summer of 2021, we began the pivot back from the camp to the Mission facilities and geared up to renew the Entertaining Angels Nomadic Shelter ministry. As we continue to emerge from this long, challenging period, we are encouraged by the thousands of lives that were impacted by the Mission and by the tremendous support from people throughout this community who love God and love the poor.

We have confidence that God will continue to use this ministry to transform lives of the least, the last, and the lost among us.

EMERGENCY SHELTER: Emergency shelter for men, women, and children experiencing homelessness. Guests are provided with warm nutritious meals, clothing, a safe place to sleep and an opportunity to hear the Gospel.

NEW LIFE RECOVERY PROGRAM: A faith-based residential substance abuse recovery program for men and women who wish to put their addictions behind them, build a support system and start a new life.

MOBILE MINISTRIES: The focus is on Luke 14:23, "And the Lord said unto the servant, Go out into the highways and hedges and compel them to come in, that my house may be filled." Mobile Ministries includes Nomadic Shelter, Search and Rescue efforts and Mobile Shower.

<u>JAIL MINISTRIES:</u> Volunteer teams that are authorized to go into the county jail and facilitate chapel services, bible studies, and one-on-one biblical support as well as provide preliminary interviews for inmates looking to be released into the New Life Program.

THRIFT STORE AND INDUSTRIAL MINISTRIES: Items donated are sold to support our programs; we also provide necessities to our community. There is also ongoing recycling in an effort to be socially conscious and eco-friendly.

<u>OUTREACH MINISTRIES:</u> Outreach events throughout the year in our community that allow you to connect with and minister to the poor and needy.

JOB SKILL TRAINING PROGRAMS: Training programs change lives giving men and women valuable training and experience in Catering, Coffee Roasting, Retail Management, Truck Driving and Forklift Operation.
